SAFE CARE PROGRAM FOR SUBSTANCE INVOLVED MOTHERS AND INFANTS:

CPC Jeff Cty was selected as one of 15 national Substance-Exposed Infant Initiative demonstration sites selected for federal funding of \$210,000. The purpose of the SAFE CARE Program is to address the emerging substance use crisis and its impact on infants and children, ensure plans of safe care are implemented for both prenatally exposed infants and their mothers with SUD. Services include care coordination for recovery, mental health, medical, early intervention, parenting and in-home education.

The SAFE CARE Program is designed to help build and retain intact families affected by substance use disorders, to ensure effective safety plans are in place for substance-affected infants and that community resources are utilized to meet the needs of their mothers and families.

This program helps mothers create plans of safe care for themselves and their infants. Each participant has a Care Coordinator providing integrated intensive case management including assisting with navigation of CPS, Family Court as well as substance abuse treatment, recovery support, parenting education, mental health services, housing, therapeutic visitation, maternal and child health, and in-home education. Participation in SAFE CARE can begin prenatally and continue from birth to 3 years of age.

Over the past year, SAFE CARE served 76 substance-involved women (34 prenatally and 42 post-partum) and 115 children through creation, care coordination and monitoring of Plans of Safe Care.

Of the 115 affected children birth to 3 years old involved with SAFE CARE during this time period, 81% were able to remain in home or relative placement;

62% of total SAFE CARE participants had no open case with DHR including those with no case ever opened (25), those who were monitored only (11), and those whose cases were closed due to child permanency at home or with relative (12).

Goal 1: Engage with pregnant and post-partum women in substance abuse treatment.

Goal 2: Rebuild and retain intact families for infants delivered to substance- involved parents.

Goal 3: Reduce the length of time for out-of-home placement for children birth to three years old.

Goal 4: Increase the collaborative capacity of the community to meet the needs of the target population. Goal 5: Engage in evaluation and performance measurement.

A 33% increase in the rate of enrollment occurred the second 6 months over the first 6 months of the year. Among referral sources, maternal/child health (41%) by far the top followed by recovery (21%) and DHR (19%) with family court at just over 10%, the CPC supervised visitation program 7% and home visiting 1%.

Referral rates and referral sources exceeded expectations. We had predicted a much smaller growth rate of referrals and total enrollments than what occurred. Secondly, we anticipated most referrals would come from family court and CPS. As awareness of the program grew, a success measure we projected was to have most referrals come from maternal/child health and recovery providers reflecting earlier screening and identification. We were delighted that 62% of referrals came from maternal child health or recovery. This enthusiastic response by health care and recovery staff speaks to their perceived need for the services provided by SAFE CARE; and to success in the identification and thus intervention with affected mothers and infants much earlier, optimally prenatally, rather than downstream post-partum through DHR and court referrals after testing positive at birth.

To address need for training and education among those having contact with the target population of affected mothers and infants, the Jefferson County SAFE CARE Program offered comprehensive trainings on Plans of Safe Care, CAPTA/CARA, SBIRT, Substance Use Disorders in Pregnant Women, Home Visiting, Fourth Trimester, Reducing Stigma. Trained have been over 350+ professionals from target sectors of juvenile justice, judges, OB/GYN practitioners, pediatricians and neonatologists, medical social workers, behavioral health staff, early intervention specialists, child protective services staff, recovery center personnel and child-serving professionals.

#### Systems Change

Screening and Identification: In the medical community we have encouraged OB/GYN practices to participate in a system walkthrough at 6 of the 7 area hospitals on how they are engaging substance involved women during prenatal care on through the birthing process. We have found that practices are reluctant to screen because they do not want to involve child welfare, or they are not equipped to handle the needs of the patient related to their recovery. Patients though their situation was fine because their physician did not address their dependency and were met with DHR at birth. We now have about 10 practices using Screening Intervention and Referral to Treatment (SBIRT) or another type of verbal screen such as the 5 P's. Both practices and delivery social workers are making the highest number of referrals to SAFE CARE. Women's Services Departments are decreasing the number of prescription medications patients are discharged with, communicating with patients and delivery staff about dependency and what to expect at birth, learning more about the 4th Trimester and putting more focus on depression screens and post-partum depression resources, adopting rooming in approaches to reduce NAS and learning more about reducing stigma and judgement around women with substance use disorder.

Post-Partum Supports: Home Visiting has participated in continuing education to learn more about the 4th trimester, post-partum depression and coping skills to decrease return to use after the new stressors arrive after having a baby. Home visiting partners usually give families time to bond by taking a step back and not visiting as often. Home visiting partners are now being more intentional about being more available post-partum, focusing on coping skills and ways in which the family can be supported to relieve stressors in efforts to reduce return to use.

Prenatal Referrals by DHR: DHR cannot make an assessment for a report given on a pregnant woman until the baby is born unless there are other children in the home. With SAFE CARE available, DHR now has the opportunity to make an early referral to the program enabling interventions to begin prior to rather than at delivery. The ability to implement a prenatal plan of safe care drastically reduces the likelihood that DHR will open a case and increases the likelihood that the woman will use that opportunity to see supports maintain custody or plan for a relative to seek temporary custody. In addition, plans of safe care allows DHR to conduct a meaningful assessment of the family situation. Often, families do not willingly share information with DHR, impeding their evaluation of the situation at hand, therefore making it difficult to decipher child safety and family needs.

Improved Judicial Outcomes: Family Court judges and attorneys are seeing the value of SAFE CARE in that we are a support system to the clients, and that all needs are addressed and monitored in the plan of safe care for both mother and child. Judges are now routinely asking SAFE CARE to be present at hearings to speak on the progress made by clients. Recovery is a journey and often clients are met with barriers in judicial, medical, social service systems that hinder their successful compliance with some matters. Given the opportunity to speak to these matters on behalf of the client sheds light on gaps and challenges clients face externally from systems affecting the navigating of their sobriety. Clients are prepared and more confident when going to court. Judges and attorneys benefit from the snapshot of their family situation gleaned from the plan of safe care, which then helps them in their advocacy and decision making for both mothers and children.

Clients Self-Accessing Services Improved through Plans of Safe Care: Parents are encouraged to share their plan of safe care with whomever is providing services to the family so that the community may assist them on their journey of sobriety and child well-being. We have seen evidence of the positive impact that has had in accessing services, responsiveness of providers to SAFE CARE clients.

Chemical Endangerment: Working with the district attorney's office related to education on the impacts of chemical endangerment laws and benefit of diversion vs. incarceration has been a priority. We have had five clients with chemical endangerment charges. This law deters women from seeking prenatal care or disclosing for fear of being arrested for dependency. Many express that they want help but hide their substance use. We have been spreading the message that speaking up and getting help will increase chances of not getting arrested and keeping custody of their child. If women come forward during pregnancy, this increases the health of mother and child. Alabama has a high maternal morbidity and infant mortality rate.

Family Reunification & Safe Connections Program: Supervised Visitation and Safe Exchange Services

The mission of the Family Reunification and Safe Connections Program (FRP Safe Connections) is to provide Supervised Visitation as well as Safe Exchange Services in a secure and comfortable setting where families can maintain their relationships, address the issues that created the need for out-of-home placement and supervised visitation, reduce trauma, strengthen parenting skills, and ensure safety in no-contact situations between parents.

In 2020, there were 1,099 protection from abuse (PFAs) orders issued by Family Court while the rate of PFA victims receiving SVE services dropped to 1.5% due to the closure of the only SVE provider in the county, the YWCA Safe Haven Program, in July 2020. This closure triggered a public safety crisis of grave concern to the courts and law enforcement as now there were zero SVE services available in Jefferson County, made worse by the COVID pandemic which was was sparking a spike in DV and assault.

In Fall 2020, the CPC was approached by court and law enforcement officials to add these SVE services for DV/PFA involved families to our existing Family Reunification Program (FRP). FRP provides supervised visitation services for DHR-involved families, children in out-of-home placement, and parents with custody disputes. The CPC agreed to do so, geared up to put into place the needed additional security measures and staffing, and began serving former YWCA Safe Haven clients and new referrals to address this urgent need, despite lack of funding, as the 2020 holidays approached, a particularly dangerous time for DV.

Context of need for funding support for SVE: SVE services are provided at no charge for victims of DV, thus external funding is always essential to offer these services. The funds from the CFGB, along with funds ought elsewhere, are critical for the CPC to continue to offer this program.

The cost of running a SVE program is much greater than regular supervised visitation due to the additional safety, security measures required. CFGB grant funds will be used for staffing and on-site security presence needed for safe exchanges and DV-involved supervised visitations. The CPC has in-kind agreements with IMPACT Family Counseling and First Presbyterian Church to use their facilities at no charge for SC SVE, which have the needed security features including locked entryways, surveillance cameras, and separate entrances. CPC offers safe and nurturing SVE services that provide for physical and emotional safety for DV victims and their children while also allowing the children opportunities to develop or maintain a healthy relationship with their non-residential parent.

CPC also collaborates with project partners including DV victim service providers and the courts in putting safety plans in place to ensure the best interest of the child is accomplished while adult issues and the validity of allegations are addressed. When that plan includes the removal of children from one or both parents, early, consistent, and frequent visits are crucial for maintaining the parent-child relationship. Our program and collaborative strategy allows parents and children to spend time together without the fear of repeated trauma, violence or manipulation and provides for improved future outcomes of safety, permanency and well-being.

When confronted with petitions for civil protective orders (PFAs) to shield victims of domestic violence from their abusive partners, courts are also often required to make decisions about the abuser's access to the couple's children. The enhanced DV education of court-affiliated personnel integral to this proposal is a critical success factor in improving rates of referrals for SVE services to help protect children and vulnerable parents from harm, while preserving the abuser's parent-child relationship.

Coaching and facilitating healthy parent/child visitation requires working with unique families with differing histories and needs. This requires skill, creativity, an open dialogue and respectful teamwork between staff, visiting parents, children, caregivers and often professional providers. Transparency is a key factor in our' success in working with families. Parents are made fully aware of all expectations for consistency, timeliness and are provided parent handbook of guidelines. The goal is to set a framework for success for each family rather than a set-up for capturing failures. Parents are all reminded of the important role they play in the development of their children and encouraged to use their time to build family strength.

Supervised Visitation Services:

Offers families with children in out-of-home placement and situations in which supervised visitation is indicated for one or both parents with the opportunity to visit in a comfortable, supportive environment. Birth parents are provided one-on-one visit coaching with a trained Supervised Visitation Coach who uses a variety of methods to help the parent address issues related to the reason for out-of-home placement and need for supervised visitation. Role modeling, coaching, psychoeducation, and feedback are tools used to help parents understand their child's emotional, developmental, and physical and the importance of playing with their children. Integrating these tools within the visits allows parents the unique opportunity to practice their parents to be intentional about each visit, such as planning activities, special celebrations or community outings. FRP Safe Connections utilizes safe and secure visitation facilities with areas for individual family time and spaces available to accommodate families with one or multiple children.

Safe Exchanges: This service is the scheduling and supervision of safe exchanges of children between custodial and non-custodial parents with histories of family violence, abuse, PFA orders. Facilitation of monitored exchanges ensures regular court ordered visitation without the adults having contact in front of the child. Safe exchange services provide safety in cases of victimized children and parents from a continuation of controlling, manipulative or dangerous behavior.

These services are designed to assist children and parents affected by out-of-home placement, custody disputes, court orders. Children suffer a great deal of trauma and loss during times of separation from family, especially caregivers. The resulting attachment disruption can intensify the possibility of detrimental adverse effects on these children. Before parents can be permanently reunited with their children, the issues that created the need for placement must be resolved. In cases of need for safe supervised visitation due to domestic violence or protection from abuse, supervised visitation is a key component of the process of safely bringing parents and children back together. Supervised Visitation in cases of out-of-home placement builds the capacity of parents and children to maintain or rebuild their familial bond, reduce the trauma of separation, increase the likelihood of successful reunification in a safe, secure, supportive setting, and enhanced safety for children and victimized custodial parents with histories of DV and Protection of Abuse Orders.

**Child Trafficking Solutions Project** 

The Child Trafficking Solutions Project, founded and coordinated by the CPC at the request of Family Court Presiding Judge Chambliss in 2016, is a broad-based coalition of law enforcement, juvenile justice, health/mental health, child welfare agencies and NGO's working collaboratively to recognize and respond to exploitation and trafficking of children through uniform response protocols, training, and strategic partnerships while mobilizing communities to prevent abuse, raise awareness and increase safety. Components of this initiative include the VOICES Trafficking Docket at Family Court; a comprehensive training program and uniform response protocol for law enforcement, child welfare, Family Court, and firstresponders; successful passage through the leveraging of CTSP allies and advocates of Human Trafficking bills and ordinances, engaging communities to commit to becoming Trafficking Free Zones across Jefferson County and the state of Alabama.

Despite COVID, the work and reach of the CTSP was the strongest since its inception, during the 12-month time frame of this report. The CTSP FB page has 1,083 followers. The CTSP monthly e-newsletter has a distribution reach to over 500 agency representatives from NGO's, courts, law enforcement, child welfare, government entities.

The CTSP continued its partnership with The World Games (now 2022) to plan and address threats of human trafficking associated with this international sporting event. The CTSP is assisting with training content and execution for its 2,500 volunteers, event staff, as well as prevention and awareness promotion and education for attendees, athletes, visitors and hospitality partners. Included is the commitment by Jefferson County municipalities including the City of Birmingham to train 100% of employees in trafficking awareness and prevention by July 2022. This represents over 6,000 employees within Jefferson County across 26 municipalities. Despite COVID, training over the last 12 months has moved forward in ways that have exceeded expectations. This has been in large part due to the pivot to live on-line training during much of the year coupled with a transition back to in-person as the year progressed.

#### **Training Statistics**

Over 2,500 individuals were trained through the CTSP Coalition during the time period of this report. Of these, 885 participated in live on-line trainings led via the CPC Go To Webinar platform. Others were trained in person through all-day, 1/2 day or one-hour trainings depending on the targeted audience. Trainings offered in-person included: AL HT Summit in Montgomery, AL statewide Judicial Conference, AL State Municipal Clerks Association, plus specific agencies, communities, counties. Included were law enforcement (Trussville PD and FD, Irondale PD and FD, Birmingham Police Academy, Birmingham PD, Lee County Sheriff, Auburn PD, Opelika PD, Pickens County LE, Tallapoosa County LE, Mountain Brook PD and FD), Jefferson County DHR staff, educators and parents from multiple school systems (Hoover, Bessemer, Homewood), statewide CASA volunteers, statewide JPO and Juvenile justice staff, Health and Mental Health professionals (JBS MHA, Children's of Alabama pediatric residents, Eastside Mental Health), faith-based organizations, Junior League of Montgomery, child-serving professionals, attorneys.

Campaign for 3rd Grade Reading:

he Jefferson County Children's Policy Cooperative will implement a new literacy project to re-launch of the Campaign for Grade Level Reading in Jefferson County (CGLR). This project is aimed at improving access to services for English Language Learners and their parents. Jefferson County boasts many community partners who come alongside our 12 school systems to offer early childhood education, child care, afterschool care, and summer programs to support reading. Despite these efforts, 80% of ELL students are not reading on grade level. Our assessment and prioritization tool revealed that most agencies do not have a language access plan nor consistently reach out to and enroll ELL students. So, the students most in need of support from birth to age eight are missing out on opportunities. Therefore, we have designed a literacy project to improve the capacity of existing agencies.

From June 2021 to December 2022, CPC will lead a new effort of our local CGLR to support the great work begun by existing agencies to improve literacy. The CPC will conduct outreach to providers identified during the assessment phase and then raise awareness in the community at-large. CPC will host a webinar on the importance of a language access plan and the connection to grade level reading for ELL students. During this event, a technical assistance grant opportunity will be announced. Interested applicants will be required to attend an online training. The training will go more in-depth on language access plans and the process for technical assistance grants. The training will include an overview on how to create a language access plan; accessing bilingual resources for kids and families; finding and using qualified interpreters and translators; and creating a welcoming environment for parents and children.

The \$20,000 Campaign for Grade Level Reading grant will allow CPC to initiate systemic change in Jefferson County. All funds will be devoted to the literacy project focused on improving the capacity of agencies to serve the needs of English Language Learners and their parents. ELL students fail to read at grade level at a higher percentage than other sub-populations, and yet our long list of supportive agencies provide very few supports for this population. Training and implementation of language access plans will provide more opportunities for ELL students and parents. In addition, these systemic improvements will bring agencies in compliance with federal guidelines making more of them eligible to receive federal funding. This improves their ability to apply for grants and potentially provide expanded services to all children.

CPC will contract with a few providers (either individuals or agencies) who have experience with the Alabama Language Access Project and have a proven ability to deliver on the proposed activities. These individuals or agencies will provide the content of the webinar trainings and devote time to technical assistance for agencies wishing to implement a language access plan. CPC will negotiate an equitable distribution of support to selected agencies. Some agencies may have an existing language access plan and need minimal support to translate documents or a website to give greater access to families. Other agencies may need technical assistance to revamp curriculum or retrain staff. The allocation of technical assistance to initiate services with Language Line (or a similar service) that provides translation via telephone.

Funds will be reserved to purchase age-appropriate books and materials in the needed languages for agencies who complete the program. CPC has access to discounts to these materials from First Book.

2020 Peanut Butter Drive: Coordinated Peanut Butter Drive in partnership with Family Court of Family Court, YMCA, Team Meadows, LLC, to collect over 3 tons of peanut butter for the Community Food) Bank in response to exponential increase in food insecurity of children and families directly related to COVID, lack of availability of school breakfast and lunches during shut-downs, job loss.

Diaper, Formula, Wipes, Feminine Products Distribution: CPC served as delivery mechanism between Junior League of Birmingham and Bundles of Hope (free diaper providers) and clients referred by agencies w who were not able to be served by normal case managers or access these supplies at these agencies due to COVID shut downs. Referral partners: Children's of Alabama, Jefferson County Health Department, the Exchange Club, DHR, Helping Families Initiative. With agency case workers not being able to go out into the field due to COVID, CPC staff members stepped in to personally deliver diapers, wipes and formula directly to the homes of families referred by these agencies, on an emergency (one-time) as well as on-going (monthly) basis. Over 2,500 diapers plus formula and wipes delivered during the time frame of this report.

#### **Holiday Hope Bags**

95 Holiday Hope Bags were prepared and delivered to mothers and their babies who are enrolled in the SAFE CARE Program. Volunteer youth who are part of YouthServe agency purchased items and stuffed 95 Holiday Tote Bags with comfort items for mom and baby and volunteers from Junior League of Birmingham delivered these directly to homes of these clients during holiday week Christmas to New Years.

#### **Essentials Closet**

The CPC maintains an Essentials Closet at Family Court of Jefferson County with essential items such as feminine products, personal hygiene products, diapers, wipes, formula, baby food, pacifiers, socks, underwear, backpacks, shoes, laundry detergent, toothbrush/toothpaste, snacks, juice boxes to have available for families and children coming through the doors of Family Court who are in crisis, without and needing basic necessities.

**Call to Order and Approval of Agenda:** At 8:33 a.m., Greg Townsend, Board Chair, called the meeting to order. He established that a quorum was present. Tonya Jones moved to approve the agenda as presented, seconded by Elaine Stephens, and followed by a unanimous approval.

**Approval of Minutes June 4, 2020 Board Meeting**: Melissa Niven, Secretary, presented the minutes from the June 4, 2020 board meeting. Polly McClure moved that they be accepted as presented, seconded by Elaine Stephens, and followed by a unanimous approval.

**Finance**: Elaine Stephens, Treasurer, presented the financial report including the financial statements for July 2020. She remarked that financials remain in a good position at this time and noted Jan Bell did a good job of cutting expenses when COVID-19 interrupted normal operations. The \$12,000 liability appearing on the statement includes EIDL and PPP funds and liability will be reduced by \$10,000 before the end of the year. At the end of the Jefferson County Court fiscal year (end of September) we expect a \$3,800 reduction in the CPC allocation from Family Court. This is a result of the 5% budget cut across the board at Family Court. An audit was completed by Kassof on July 27, 2020 and received a clean, unqualified opinion from the auditor. Joan Wright moved to accept the audit report, seconded by Melissa Niven, and followed by a unanimous vote of approval. In response to COVID, Gov. Ivey has set aside funding for nonprofits. Jan has applied for \$15,000, but this has not yet been awarded. Elaine Stephens moved to accept the financial report, seconded by Tonya Jones, and followed by a unanimous vote of approval.

**Family Court Update:** Vanessa Jones, Deputy Court Administrator, expressed gratefulness for our forward thinking. All budgets were cut by 5% across the board. Judge French has fully opened Courts to the public with social distancing measures. Many cases are still being heard virtually. Allison Deering has advocated for victims in Protection from Abuse (PFA) cases to have an advocate present with them when the case is heard virtually. Kiosks for frequently asked questions will soon be operational. **CPC Operational Update:** Shajuane Jones, Program Director, provided an update on SAFE CARE including successes and results from April 2019 – August 2020. A national all-sites meeting was held virtually and a no-cost extension will allow funds to be expended through the end of the year. Morissa Ladinsky commented that the program gives providers a solution that works when faced with a pregnant woman who discloses substance use. George Casey highlighted CPC's national recognition and Shajuane's diligent effort. Greg Townsend encouraged board members to share this information with the broader community. Polly McClure volunteered to lead the public relations outreach efforts. Greg Townsend suggested forming a small committee to conduct community outreach and instructed interested board members to contact Jan.

Jan Bell, Executive Director, proceeded with the operational update. CPC will help promote the Peanut Butter Campaign to drive donations to the food bank. FRP is conducting virtual visits and transitioning to in-person visits, but location is a challenge due to COVID-19 restrictions. Child Trafficking trainings have expanded their reach through virtual platforms, First Friday Forums continue to be successful, and the Essentials Closet is operational. Jan and Shajuane are making deliveries of rapid response resources to homes. CPC is promoting the 2020 Census.

Melissa Niven, Secretary, gave an update on the Campaign for Grade-Level Reading.

**Child Trafficking Solutions Project:** Greg Townsend, Board Chair, led a discussion regarding the Child Trafficking Solutions Project spinning off into a separate 501(c)3 nonprofit. Input and information was provided by Executive Committee members. Elaine Stephens moved to spin off the CTSP into a separate 501c3 entity, seconded by Natasha Shumpert, and followed by a unanimous vote of approval.

**CPC Board Member Check-ins:** Greg Townsend, Board Chair, conducted a brief discussion of the agency needs and services available through CPC board members. The following board members gave updates: Terri Harvill, Joan Wright, Julie Pearce, Melissa Niven, and Natasha Shumpert.

Adjournment - There being no further business, the meeting was adjourned at 10:00 a.m.

**Call to Order:** At 8:36 a.m., Greg Townsend, Board Chair, called the meeting to order. He established that a quorum was present.

**Approval of Minutes August 28, 2020 Board Meeting:** Melissa Niven, Secretary, presented the minutes from the August 28, 2020 board meeting. Tonya Jones moved that they be accepted as presented, seconded by Greg Townsend, and followed by a unanimous approval. Minutes from the 10/16/2020 Executive Committee meeting were included in board packets ahead of the meeting for review.

**Finance**: Elaine Stephens, Treasurer, presented the financial report including the financial statements for September 2020. She remarked that financials remain in a good position at this time. She reviewed current cash balances and the status of PPP and EIDL loans. FRP has billed for reimbursable expenses, but not yet received these funds. CPC has submitted a request to Jefferson County Family Court for our contracted amount. Melissa Niven moved to accept financials as presented. Motion was seconded by George Casey and unanimously approved.

Elaine Stephens, Greg Townsend, and Jan Bell have thoroughly reviewed the IRS Form 990. Elaine Stephens moved to accept the IRS Form 990, seconded by Tonya Jones and followed by a unanimous vote of approval.

**Family Court Update:** Vanessa Jones, Deputy Court Administrator, updated our board members on the changes coming to Family Court. These included a check-in kiosk where individuals sign in and receive a number that will be flashed on the screen to provide more anonymity and prevent calling names aloud in the hallway. Jefferson County is beginning to look at telework options for some court employees.

Brian Huff and Quintin Brown will come as special judges to get the backlog of PFA cases and child support cases caught up beginning on November 2, 2020. Judge Cousins is determining how PFA cases are heard.

**Approval of Agenda:** As it was overlooked at the beginning of the meeting, Melissa Niven made a motion to accept the meeting agenda as presented. Elaine Stephens seconded and the agenda was unanimously approved.

Advocacy Update: Angelica Melendez, Chair of the Advocacy Committee, was unable to attend, so Jan Bell invited board members who presented at the committee meeting to give updates. Jean Hernandez reviewed the concerns over mental health care in juvenile facilities and the impact of COVID-19 on children's issues. Melissa Niven updated the board on a bill for statewide due process protections for students facing exclusionary discipline. Morissa Ladinsky updated the board that a bill has been pre-filed in both the House and Senate that would restrict physicians in their ability to provide hormone therapy to minors who identify as transgender regardless of parental consent.

**Board Governance Update:** Julie Pearce, Governance Chair, reported out that the committee is forming a nominating committee and currently reviewing the needs for the new year. She invited board members to contact her with ideas regarding the skill sets and agencies needed on our board.

**New Business**: Greg Townsend gave personal commentary regarding a domestic violence incident that happened in his neighborhood and reminded board members of the importance of these services. Greg Townsend, Board Chair, had to leave early and asked Tonya Jones to assume control of the meeting. Tonya Jones invited Jan Bell to present new business.

Jan Bell provided an update on SAFE CARE and FRP. The SAFE CARE grant ended September 30, 2020 and an extension on the use of funds was granted through the end of the year. The board has been discussing the need to incubate and transition this program for more than a year. IMPACT Family Counseling has been identified as the permanent home for both SAFE CARE and FRP.

George Casey affirmed that SAFE CARE/FRP share overlap in program services and mission alignment with IMPACT Family Counseling where he serves as Executive Director. IMPACT desires to be the home for the program so that these vital services do not end. The agency has the ability to continue services and make the program sustainable. Plans are to keep the staff and clients and transition to management by IMPACT Family Counseling.

Tonya Jones expressed her support for this transition. Elaine fully supports this transition from a financial perspective and in terms of appropriate facilities. Morissa Ladinsky expressed support because IMPACT understands the complexities our families face. Melissa Niven expressed her support and confidence in George Casey's leadership and expressed that good communication and collaborative partnerships are key in transitions and we have both in George Casey. Katrina Watson asked whether there would be stability in the staffing. George expressed the desire to keep the current staff. Julie Pearce expressed that this is a good fit. She additionally raised that we protect both agencies by recording the additional agencies considered in our search.

Jan Bell recapped the agencies considered in the due diligence phase:

- 1) Exchange Club (Stacy Hopkins) A current partner with similar program offerings.
- 2) Family Guidance Center A collaborative partner in case management.
- 3) Children's Aid Society A current partner.
- 4) CPC keep the program

Ultimately, these other options were not the best fit in terms of willingness to take on the programs, facility, and financial position. IMPACT Family Counseling was the best choice.

Tonya Jones asked about the timing of the transition. If approved by the board, Shajuane Jones and the IMPACT staff will begin job shadowing and the transition team will determine the timeline. Transition team includes Greg Townsend, Elaine Stephens, George Casey, Melissa Niven, Julie Pearce, Jan Bell and Shajuane Jones.

George Casey had to leave the call at 9:43 a.m.

Elaine Stephens expressed the desire to have a solid financial transition and that CPC is in a financial position to assist with funding the transition.

Elaine Stephens moved that CPC transition the SAFE CARE program and the FRP program to IMPACT Family Counseling. Morissa Ladinsky seconded the motion. Toyna Jones called for a vote and no board members opposed, all members approved, and there were no abstentions. George Casey had previously left the meeting prior to the vote to avoid conflict of interest.

Jan Bell updated the board that the YWCA will no longer be providing supervised visitation and safe exchanges for Protection from Abuse (PFA) cases. Jan informed that she and the EC committee are currently doing due diligence to determine if we can take this on between now and the end of the year. This includes evaluating our insurance liabilities. It also includes George Casey's board reviewing and voting on whether they are comfortable with this type of activity in their facility. The IMPACT board meets November 19<sup>th</sup>. Jan is also looking for additional community partners who may be able to meet this need. More information will be provided to board members as available.

**CPC Operational Update**: The JLB contract for FRP for the new year has begun. Orientation and visits begin this week. YMCA is discussing reopening their facility for FRP use. CPC is currently providing trafficking training (including in-person trainings with COVID precautions). The Peanut Butter Drive was a success. The goal was two tons of peanut butter and CPC raised five tons!

**Board Member Check-in:** Tonya Jones has left JCCEO and is now working with Childcare Resources as Head Start Director. Natasha Shumpert reported that JCDH has a pediatric drive thru COVID testing site available. Melissa Niven is co-hosting an SPLC webinar with Sen. Smitherman on Tuesday, November 10<sup>th</sup> regarding due process protections for students. Jan is seeking a program for First Friday Forum in November.

Adjournment – There being no further business, Tonya Jones adjourned the meeting at 10:04 a.m.

**Call to Order:** At 8:46 a.m., Greg Townsend, Board Chair, called the meeting to order. He established that a quorum was present.

**Approval of Agenda:** Natasha Shumpert made a motion to accept the meeting agenda as presented. George Casey seconded the motion and the agenda was unanimously approved.

**Approval of October 20, 2020 Board Meeting Minutes:** Melissa Niven Sherer, Secretary, presented the minutes from the October 20, 2020 board meeting. Jean Hernandez noted a correction. Jean was in attendance at the 10.20.2020 meeting. Julie Pearce moved that the minutes be accepted with the correction of adding Jean Hernandez as in attendance, seconded by Elaine Stephens, and followed by a unanimous approval.

**Financial Report** Elaine Stephens, Treasurer, presented the financial report including the financial statements for November 2020. She remarked that financials remain in a good position at this time. CPC has until May to make the first payment on the PPP loan, but it does look like CPC will have to pay back the \$10,000, so it is held as restricted. It is still very unclear whether any portion of this will be forgiven. In November 2020, Jefferson County Family Court amended our contract to pay us quarterly instead of annually. We have not yet received our first quarter payment as the contract amendment has to be approved by the Jefferson County Commission. In January 2021, we will be due our second quarter payment. The two unusual items of note are a charge for a certification for Shajuane and the Peanut Butter Drive. Jan Bell remarked that Junior League supplies are reimbursable, and the income will come in 2021. Also, the DHR billing for FRP will be receivable in 2021. Tonya Jones moved to accept financials as presented. Motion was seconded by Polly McClure and unanimously approved.

Family Court Update Vanessa Jones, Deputy Court Administrator was unable to attend as she is on leave.

**Board Governance** Julie Pearce, Governance Chair, reminded all members of their commitment to financially support CPC through board giving. Our goal is 100% participation. Julie recognized the board members rotating off this term: Tonya Jones (Vice Chair), Sybil Scarborough, Joan Wright, Aryn Sedgwick, Paul Morin, Polly McClure, and Katrina Watson. Joining us to begin new terms will be Adrienne Marshall (Literacy Council of Central Alabama) and Kim Braasch (United Ability). Julie presented the new slate of officer nominations: Greg Townsend, Chair; Melissa Sherer, Vice Chair; Natasha Shumpert, Secretary; Elaine Stephens, Treasurer; and George Casey, At-Large. Elaine Stephens moved to accept the new slate of board members and officers for 2021 as presented. Katrina Watson seconded and the motion was unanimously approved by vote. Jan Bell echoed her gratitude for the service of the board members completing their terms of service.

CPC Operational Update Jan Bell, Executive Director, presented the Operational Update.

**Campaign for 3<sup>rd</sup> Grade Reading :** Jan Bell invited Melissa Niven Sherer to give a brief update on the Campaign for GLR. Our CPC will lead the CGLR in our community and is currently meeting on a regular basis with Liletta Jenkins.

**Child Trafficking**: Jan received the FBI Community Leader Award for the CPC work in the Child Trafficking arena. A virtual award program was held last month and they sent an award which will be presented to Judge Janine-Hunt Hilliard. Training for law enforcement, schools, and community members on preventing child-trafficking increased in 2020 as we moved to virtual training. Municipalities are continuing to make Anti-Trafficking declarations ahead of Trafficking Awareness Month in January.

**SAFE CARE:** Jan gave a program update on SAFE CARE. The grant is ending and Shajuane is completing data reports. There are currently 50 clients. YouthServe has prepared Santa gift bags for moms/babies enrolled in SAFE CARE. Shajuane and SAFE CARE are currently beginning to transition to Impact Family Counseling. Impact has a team in place to support SAFE CARE and Shajuane. Casey Family Programs conducted listening sessions in December and SAFE CARE and Helping Families Initiative were mentioned often as a possibility.

**FRP and Safe Connections Program:** Jan gave an update on the Family Reunification Program (FRP). The name has been changed to FRP and Safe Connections Program. The first safe exchange will occur today (12/18/2020). First Presbyterian Church will be the location for safe exchanges. Program Coaches help reduce anxieties for clients to ensure successful exchanges and visitation. Domestic Relations judges, Family Court judges and the YW are making referrals. In addition, FRP is going well. The goal is to increase the census in the first quarter of 2021 and transition the program to Impact Family Counseling in the second quarter of 2021. The YW hosted a domestic violence prevention training on Zoom and 100% of the program coaches attended.

Elaine Stephens moved to accept Jan's program report as presented. George Casey seconded and it was unanimously approved.

Jan added that the delivery of diapers to those in need has been a hugely successful service during the pandemic. Also, it was noted that Robbie Roberts (Chair of Early Care Network) has retired.

**CPC Board Member Check-Ins** Greg Townsend invited board members to share updates. Tonya Jones mentioned new Head Start programs are opening in January and they are looking to purchase a facility. Natasha Shumpert mentioned that the JCDH is in need of new, unused car seats for children. Morissa Ladinsky and Julie Pearce offered to brainstorm solutions.

**Call to Order and Roll Call:** Greg Townsend (Board Chair) began the meeting by requesting a moment of silence to honor individuals diagnosed with COVID-19 and those who have passed away from COVID-19. At 8:33 a.m. the meeting was called to order.

**Introductions:** Jan Bell (Executive Director) facilitated introductions with a request for board members to provide information about themselves and their organization for the benefit of new members.

**Approval of Agenda:** Melissa Niven Sherer (Vice Chair) moved to approve the meeting agenda as presented, Elaine Stephens seconded the motion, and followed by a unanimous approval of the agenda.

**Approval of December 18, 2020 Board Meeting Minutes:** Greg Townsend presented the December 18, 2020 board meeting minutes. No corrections noted. Natasha Shumpert (Secretary) moved to accept minutes as presented, Elaine Stephens seconded, and followed by a unanimous approval of the minutes.

**Financial Report** Elaine Stephens (Treasurer) presented the financial report and statements for December 2020. She commented that finances are currently in good position. The CPC received a \$17,000 federal PPP loan. There are \$15,000 remaining from state funds and \$10,000+ held in trust from LGBTQ for Nadia Richardson. All is consistent for entering the new year. There was a \$2,000

corporate contribution for SAFE CARE and a 45-day lag between billing and receiving funds. All annual revenue is not reflected in December financials. Therefore, assets are not negative. The CPC did have a net loss this year and are operating in a deficit due to COVID-19 constraints as well as the Child Trafficking Solutions Project. The CPC operates on a cash basis, meaning it is recorded when received, not on an accrual basis. Jan bell added professional fees are for an honorarium for paying survivors to speak at trainings. No questions were noted. George Casey moved to accept the financials as presented and Melissa Niven Sherer seconded it. Financials were unanimously approved.

**Family Court Update:** Vanessa Jones (Deputy Court Administrator) stated COVID-19 impacted partnerships and services, but they are returning to a sense of normalcy. University of Alabama-Birmingham began a new lab service on Monday and WVA is interviewing for a current vacancy. Greg Townsend requested additional information on the number of clients being assisted. Ms. Jones replied, there are about 30 youth in detention. They have seen a marked decline in cases, around 100 or so, which may be attributed to a decrease in juvenile crime or other factors. Family Court update completed and no additional questions noted.

**Board Governance:** Julie Pearce (Governance Chair) acknowledged the information sheet and conflict of interest form emailed to board members prior to the meeting. She explained the importance of forms and their protective capacity. Ms. Pearce said each year board members are asked for a financial contribution to support the CPC and lend their skills and talents in other areas. Board members were reminded to complete and return forms to Jan Bell. Governance update completed and no additional questions noted.

**FRP and Safe Connections Program:** Jan Bell (Executive Director) provided information about how the CPC can incubate programs until they become more sustainable. The FRP program was recently rebranded to include a co-name of safe connections, which is more reflective of the full scope of work being done. The Supervised Visitation Exchange component of the program aids clients who have a domestic violence interface which may include one offending parent and one surviving parent. Two service locations for save exchanges are Impact Family Counseling and the YW. First Presbyterian Church assists is a key partner when an alternative location is needed. Captain Jackson, an off duty police officer, provides security onsite. Exchanges usually occur on Friday and Sunday nights. A half million dollar federal grant was submitted with Impact Family Counseling as the fiscal agency to continue program operations. FRP and Safe Connections update completed and additional questions were answered as applicable.

**SAFE CARE:** Jan Bell (Executive Director) presented an update on the SAFE CARE program. Their threeyear federal grant ended in October and George Casey, with Impact Family Counseling, agreed to absorb the program. After the grant ended, additional funds were carried over given some staff layoffs. The CPC will continue to exhaust those funds in support of SAFE CARE. A sustainability plan was mapped out with Dr. Wilson, County Health Officer, who has been involved with the program since the onset. Shajuane Jones, Program Director, will shift to Impact at some point. The program has since received several referrals from judges, hospitals, DHR, etc. All are passionately committed to ensuring the program's longevity. SAFE CARE update completed and on additional questions noted.

**Campaign for Grade Level Reading:** Melissa Niven Sherer (Vice Chair) stated the campaign was kicked off by the governor's office in partnership with the United Way, who assigned the CPC as an anchor agency. Each of the six pilot sites have monthly meetings and regular meetings with Liletta Jenkins. Community partners, including Reach Out and Read, Birmingham Talks, etc., have been tasked with

formulating a community action plan. Grant funds of \$20,000 can be obtained to assist with plan implementation within the first two years. The grant application is due at the end of February. She added that data reveals an obvious discrepancy between 18 schools with about 50% of students not reading on grade level. Though percentages vary by districts, data supported a need to focus on early access to reading, cultural and language barriers. Ms. Niven invited interested members to reach out to her directly to get involved.

**Child Trafficking Solutions Project**: Jan Bell (Executive Director) discussed getting a commitment from the Mayor's Association to recognize January as Human Trafficking Awareness Month in each city of Jefferson County. Trafficking rates are increasing. There was a training last night with about 209 CASA volunteers participating. The next priority for the project is to secure 501C3 status. Child Trafficking Solutions Project update completed and on additional questions noted.

**Ongoing CPC Work**: Jan Bell (Executive Director) stated that First Fridays Forums and other CPC work continues.

**CPC Board Member Check-Ins:** Greg Townsend asked board members to share updates. Morissa Ladinsky requested information about when JCCEO and Hand in Hand will re-establish home based services and when pre-k programs will return to face-to-face instruction. She stated that Moderna is enrolling for pediatric COVID-19 vaccine trials and are in need of a diverse group of subjects. Next week, she and her colleagues will address 150 drug/circuit court judges in Muscle Shoals, AL for expansion of MAT. Kim Braasch commented that early intervention services may return in March for others, but United Ability is operating at full capacity for in house children services. There is a waiting list for services. Greg Townsend added updates for the status of work being done around creating declarations of resolutions and amendments declaring racism as a public health crisis for the state of Alabama and verbalized support of these initiatives.

**Adjournment:** With no further business to discuss, the board meeting was adjourned at 9:42 a.m. by Greg Townsend (Board Chair).

Call to Order: Melissa Niven Sherer (Vice Chair) called the board meeting to order.

**Approval of Board Meeting Minutes:** Melissa Niven Sherer (Vice Chair) presented the January 29, 2020 board meeting minutes. Elaine Stephens moved to accept minutes as presented and Meesha Emmett seconded, for a unanimous approval of the minutes.

**Financial Report:** Elaine Stephens (Treasurer) provided information on the financial status of the CPC and reviewed pertinent financial statements with board members. A Paycheck Protection Program loan for \$12,701 and a \$10,000 Economic Injury Disaster Loan was received.

**Family Court Update:** Vanessa Jones provided an update from Family Court, reporting that this was budget time for Jefferson County. She did not anticipate any cuts being made in 2022 that would affect the CPC. Related to COVID, she reported that Judge French, presiding judge for the 10<sup>th</sup> District, has maintained the keep mask in place order for court buildings and personnel.

**Board Governance:** On behalf of Julie Pearce, Jan Bell reminded Board members to complete and return the Board information sheets, conflict of interest forms and to make an annual contribution at any level desired to achieve the goal of 100% board giving.

**Campaign for Grade Level Reading:** Melissa Niven Sherer (Vice Chair) stated \$20,000 was received for the literacy project targeting English language learners. The goal is to think beyond school to be more inclusive of all supporters of those students. Some objectives include collaborating to increase the number of childcare slots available by

increasing the number of at home daycare sites and better coordinate services between mental health and school systems. The seven impact areas are outreach, awareness, training, application, technical assistance, implementation, and project completion. Other partners working in this space include the United Way Bold Golds Coalition, Birmingham Business Alliance, Childcare Resources, etc.

**CPC Operational Update:** Jan Bell (Executive Director) provided an update for CPC programs. Potential funding sources at the local, state and federal level is being sought for sustainability of the Safe Care and Supervised Visitation Exchange (domestic violence) programs. Funding applications have been submitted to the Community Foundation of Greater Birmingham (\$25,000 for one year), Office of Violence Against Women (\$550, 000 over three years), the JCDH Public Health Advised Fund (\$80,000 over two years), and the Daniel Foundation (\$25,000 for two years). Applications will be submitted to the Women's Fund (\$15,000), Caring Foundation (\$10,000), Children's Trust Fund (up to \$150,000), and Department of Human Resources (DHR) Child Abuse Prevention and Treatment Act. The Junior League of Birmingham committed \$5,000 to assist as well.

Melissa Niven Sherer asked a question about whether all funds would come in to CPC. Ms. Bell explained the fiscal agent would vary depending on the type of grant. For instance, some federal grants may go to Impact Family counseling due to the CPC not having capacity to manage them, while some local grants may go to the CPC. Several of the funds being applied for will be exhausted by the end of the fiscal year.

**Safe Care:** Shajuane Jones joined the meeting to provide updates for the Safe Care program. Safe Care has been operational since 2019 and relies on partnerships with hospitals, DHR, Alabama Perinatal Quality Collaborative, and others for referrals. Information reflected 131 referrals received and 93 families served by the end of March (1<sup>st</sup> quarter of 2021). Year to date (2019 - 2021), a total of 26 families have successfully completed the program. Out of 55 current Safe Care participants, 22 did not complete the program, 22 declined participation for various reasons, 16 did not respond, and five enrollments are pending. Ms. Jones said the meaning of success varies and can encompass parents who are sober and maintain custody of their children or parents who are sober or in recovery, but their children reside with relatives. There are 39 children in Safe Care who remain with their parents, 24 in relative placement, and 10 in foster care. Plans of safe care and education are incorporated into discharge plans at hospitals as an extension of support to parents. Ms. Bell wrapped up by commenting that staff in place prior to COVID-19 was more comprehensive to link all partners and assist clients navigate systems. Vacant positions are needed to strengthen the Safe Care Program and provide full time case management/case coordination.

Adrienne Marshall asked a question regarding if Safe Care families included only drug related issues or if other addictions, like gambling, were included. Ms. Jones responded by saying the program is for substance involved infants exposed during pregnancy.

**Family Reunification Program:** Jan Bell stated the FRP and private philanthropy are opportunities to grow revenue and support case management and coordination services at the CPC. There are 33 active families (November 2019end of year) involved in the FRP program. Referrals are expected to increase with the transition of DHR staff from remote work back into the office. Due to turnover rates, new DHR staff will need to be briefed on what the FRP program is. Reimbursement rates are higher for DHR and those funds are needed for sustainability of the program. There are five new coaches in the program alongside a manager, who works 15-20 hours per week. Training is more intensive and they now have bilingual capabilities. Ms. Bell commented that there are no other service providers doing this work; except private providers.

**Child Trafficking Solutions Project**: The CPC is working with the world games team and others to address child trafficking concerns and establish traffic free zones. There is no expense for operating this program, only time and effort commitments from volunteers. The focus is on providing access to training, prevention, and awareness in schools. Survivor care and housing assistance is also being offered. Incorporating virtual training opportunities have expanded the reach while in the COVID-19 pandemic. First Friday Forums showed 352 registered participants for training January – April 2021 with 370 for online human trafficking training and 101 for the Early Childhood Education

work group. There was an additional face-to-face training in Opelika, AL. accommodating 55 attendees. Continued efforts will be applied in the child trafficking space.

**CPC Board Member Check-Ins:** Melissa Niven Sherer (Vice Chair) requested attendees provide an affirmation that touched them today or an area where support is needed. Participants responded accordingly.

Adjournment: With no further business to discuss, the board meeting was adjourned at 10:00 a.m. by Melissa Niven Sherer (Vice Chair).

**Call to Order:** Greg Townsend (Chair) welcomed members to the call and shared positive reflections. Melissa Niven Sherer (Vice Chair) called the meeting to order at 8:36 a.m. as Mr. Townsend had technical issues with his internet connection. Mr. Townsend rejoined the remainder of the call via telephone.

**Approval of Board Meeting Minutes:** Natasha Shumpert (Secretary) presented the meeting minutes from April 30, 2021 and made a motion to accept them pending discussion of any edits or revisions. Julie Pearce seconded that motion, for unanimous approval of minutes as is.

**Financial Report:** Elaine Stephens (Treasurer) stated that we are in "phenomenal" shape when it comes to finances. The general checking account consists of funds for the 3<sup>rd</sup> grade reading program, Jefferson County Department of Health (JCDH) funds, and court funds. There is \$68,842 in restricted or reserved funds containing the PPP loans, local foundation grants, state grants, and funds for Dr. Nadia Richardson. According to Ms. Stephens, there are no surprises in the profit/loss statement, which accounts for all revenue and expenses. The report indicates a positive net income (with the exception of the Family Reunification Program (FRP)). However, the negative balance will be modified once outstanding billing is received.

Ms. Stephens stated that additional check writers are needed. Two signatures are required for each check and all supportive documentation is attached. She noted that the organization has good internal controls and there is an audit on file indicating such. Ms. Stephens recommended she and George Casey stay on as check writers and made a motion to add Melissa Sherer and Natasha Shumpert. The motion was seconded by Julie Pearce and passed unanimously.

Family Court Update: Vanessa Jones provided an update for family court. The judge entered an order today requiring

all individuals wear a mask until November. In person hearings are being held currently, but may return to virtual hearings given the status of the Delta variant during COVID-19. Additional changes will be made in effort to keep people safe. There was a health/job resource fair on July 9<sup>th</sup> with over 65 vendors gathering outside in the front parking lot. Resource materials and other information was provided to participants. Family court had a diaper drive in the month of May, which was also successful. Family court is taking donations of suitcases for children in the foster care system. They are also collecting back to school supplies beginning today through next week. Donations of supplies and suitcases can be dropped off onsite in the Birmingham and Bessemer locations. Family court is looking to do many more similar events in the future.

• Greg Townsend requested follow-up information on the specifications for suitcases needed for children.

**Campaign for Grade Level Reading:** Melissa Niven Sherer (Vice Chair) and team were invited to present at the national conference for grade level reading. The main goal of the project is to build capacity for existing child serving agencies to improve language access for children birth to 8 years and provide technical assistance to partners. This program also offers an opportunity for board members to volunteer their time to engage community partners through small working groups held on Zoom. A \$20,000 grant was received from the CPCs to support this work. Ms. Sherer will send an email following the board meeting to solicit volunteers and provide additional details.

- Dr. Ladinsky asked whether the initiative would allow medical providers to refer children and families who need assistance with locating literacy resources. Ms. Sherer replied that this will not address all issues with grade level reading at this time, but is a starting point to increase capacity around this issue. Dr. Ladinsky volunteered to assist where needed.
- George Casey said the program resembled Summer Adventures in Learning (SAIL) and asked if they would be working together. Ms. Sherer replied that they have several community partners, including SAIL.

**Child Trafficking Solutions Project**: Jan Bell (Executive Director) sent a press release with additional information about child trafficking. They continue to work with communities and organizations to establish trafficking free zones. The process involved, providing a proclamation and implementing it. County and city employees, first responders, etc. are trained and policies are exchanged between human resource agencies. Local multidisciplinary teams are then created to include law enforcement, family court and the Department of Human Resources. Additional individualized factors may be considered for each community. Virtual services are provided statewide in various counties. Despite the barriers and COVID-19, the project has continued to progress forward and is currently being evaluated for sustainability. One option is to create a 501(c)(3) and the other is to find a home for the project. Two technical assistance grants were received to support the program and conversations are under way with the Children's Aid Society to consider housing the project.

**Family Reunification Program- Safe Connections:** Jan Bell (Executive Director) shared a spreadsheet with FRP details related to participants and pay status. There are 33 active families (including 49 children), eleven families pending (containing 20 children), and 24 inactive families. There is a training scheduled for August to orient supervisors and staff at DHR. About \$30,000 has been received to support the program. Additional grants have been applied for, including the Children's Trust Fund, the Women's Fund, etc.

George Casey spoke about transitioning FRP staff from the CPC to Impact Family Counseling as of August 1<sup>st</sup>.
 Each employee will get a slight bump in pay. There will be no major changes in expectations. Meetings were conducted to discuss the transition and answer questions, all contracts are in place for a successful transition.

**Safe Care:** Jan Bell (Executive Director) provided information and pictures regarding program participants. To date, there are 108 families enrolled from 147 total referrals. Safe Care is primarily managed by Shajuane Jones, with Sharon Greenhill assisting on a part time basis. Ms. Jones will not transition to Impact Family Counseling at this time.

More funds to support the program have been received and additional funds will be applied for to hire staff to support Ms. Jones and fund the Red Cap database. Funding agencies include the Department of Mental Health, JCDH, the Daniel Foundation, the Caring Foundation, etc.

**Transition Planning- CPC Leadership:** Greg Townsend (Chair) offered praises and gratitude for work done by Jan Bell (Executive Director) for the past six years. He informed board members that Ms. Bell is resigning from her role as Executive Director of the CPC to take a position with the University Of Alabama- Birmingham School Of Public Health. Under the guidance of Beth Johns, Ms. Bell's new role will consist of working as a Project Manager to assist school systems to ensure children and staff are transitioned back to school safely during the COVID-19 era. Ms. Bell indicated that she is excited about her new role, but will also be available to assist with remaining CPC tasks.

• Greg Townsend (Chair) stated the executive board is moving quickly to put processes in place to handle this transition. A hiring process will be developed and a plan put in place to notify partners. Board members will receive an email notification regarding the process moving forward. Mr. Townsend recommended board members with remaining questions stay on the call following the meeting.

**Adjournment:** With no further business to discuss, the board meeting was adjourned at 9:57 a.m. by Greg Townsend (Chair).
